2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the pancreatic cancer diagnosis. The topic is within the scope of the WJG. (1) Classification: Grade C, Grade C and Grade D; (2) Summary of the Peer-Review Report: Reviewer# 03882290 pointed out that authors developed CNN which detects pancreatic cancer. It is important and interesting, but there are several concerns to be raised. The authors need to discuss the other</p>	[Y]

tumors in the limitation part. Reviewer# 02482060 think this is an interesting paper, but there are some points need to be addressed. The authors did not provide the numbers of patients and CT images they used in this study. The authors need to provide the data regarding the tumor sizes. Reviewer# 03892684 thinks the dataset size is reasonable, the work is interesting, but there are a number of issues that need to be addressed. Proofreading by a native English speaker is strongly recommended. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 3 figures. A total of 26 references are cited, including 15 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade C. Although the authors provided the language editing certificate issued of AJE, the language needed to be further improved. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Natural Science Foundation of China. The topic has not previously been published in the WJG. The corresponding author has published 2 articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I
