The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: Reviewer#03000422 pointed out that authors demonstrated the predictive value of alarm symptoms in patients with dyspepsia. The point of view is interesting. However,</p>	[Y]

there are some problems that should be addressed. Authors should describe clearly about the anemia in method. The authors need to add more details in the “method” section. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 2 figures. A total of 39 references are cited, including 9 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. The highest single-source similarity index in the CrossCheck report showed to be 9%. Please rephrase these repeated sentences. The authors need to fill out the STROBE checklist with page numbers. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has published 1 articles in the WJG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references.
