The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This is an important work which should be helpful for clinicians (gastroenterologists and other fields of internal medicine) in their everyday work with patients. However, there are some issues should be addressed. A table which</p>	[Y]

details the pharmacological characteristics of oral and IV iron preparations, their advantages and disadvantages should be added. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 2 figures. A total of 42 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form, and the PRISMA checklist form. The authors need to provide the Copyright License Agreement signed by all authors. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by OM Pharma. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. This manuscript is the resubmission of Manuscript No. 36605 (Rejected). 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not write the “article highlight” section. Please write the
