The topic is within the scope of the WJG. (1) Classification: Grade A;</p> <p>(2) Summary of the Peer-Review Report: In this article, the authors described how they designed the first platform using artificial</p>	[Y]

intelligence in order to predict pancreatic fistula after pancreaticoduodenectomy. The model is accurate, easy to use, and should be seen as an asset; and (3) Format: There are 2 tables and 2 figures. A total of 49 references are cited, including 29 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by World Editing was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Research Foundation of Korea, and the Bio & Medical Technology Development Program. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) DOI numbers are missing in the reference list. Please provide the DOI citation numbers to the reference list and list all authors of the references.
