2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a retrospective cohort study of the clinicopathologic features and survival duration after surgery for gastric cancer. The topic is within the scope of the WJGO. (1) Classification: Grade A, Grade B and Grade B; (2) Summary of the Peer-Review Report: The article is innovative. The sample size is very big, and the methods are</p>	[Y]

reasonable. The increasing detection of early gastric cancer and more standardized surgical treatment effectively prolonged lifetimes. Overall, the manuscript is very well written. Some minor language polishing should be corrected. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 3 figures. A total of 50 references are cited, including 24 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade B, Grade B and Grade B. A language editing certificate issued by AJE was provided.

3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form and informed consent. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search.

4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJGO. The corresponding author has not published articles in the BPG.

5 Issues raised: (1) I found the title was more than 20 words. The title should be no more than 20 words; (2) I found no "Author contribution" section. Please provide the author contributions; (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the

	<p>editor; (4) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (5) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p><b>Editorial Office Director:</b> I have checked the comments written by the science editor.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, the full text of the manuscript and the relevant ethics documents, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions.
