better clarified. Authors should discuss briefly whether IBD patients are at higher risk of developing Covid-19 also based on speculative basic data. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table. A total of 30 references are cited, including 22 references published in the 2020. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade A. The manuscript is from the United States. 3 Academic norms and rules: The authors provided the signed Copyright License Agreement. The authors need to complete the Conflict-of-Interest Disclosure Form. No academic misconduct was found in the CrossCheck and Bing search. The repeated section is the reference list. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has published 2 articles in the BPG. 5 Issues raised: (1) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (2) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name, with no spaces; (3) The authors need to complete the Conflict-of-Interest Disclosure Form; and (4) we suggest the authors change the manuscript type to "minireview". 6 Re-Review:
