(1) Classification: Grade D and Grade C; (2) Summary of the Peer-Review Report: The authors reported a rare and interesting case, but the novelty should be added in it. The question raised by the reviewer should be answered; and (3) Format: There are 3</p>	[Y]

figures. A total of 15 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Beijing Municipal Science & Technology Commission of China. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); and (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor;. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
