(1) <b>Classification:</b> Two Grades B and Grade C; (2) <b>Summary of the Peer-Review Report:</b> The manuscript has important value, as COVID-19 has become a critical challenge to global health. references and suggestions for medical personnel during the pandemic period of COVID-19. The questions raised by the reviewers should be answered; and (3) Format: There are 3 figures. A total of 26 references are cited, including 23 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Three Grades B. A language editing certificate issued by Guangdong Yaowen Biological Technology Co. Ltd was provided. 3 Academic norms and rules: The authors provided he signed Conflict-of-Interest Disclosure Form and Copyright License Agreement; the written informed consent of surgery and treatment was not provided. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) the written informed consent of surgery and treatment was not provided, please provide the written informed consent of surgery and treatment signed by the patients; (3) the authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list

	<p>and list all authors of the references. Please revise throughout; and</p> <p>(5) The “Case Presentation” section was not written according to the Guidelines for Manuscript Preparation. Please re-write the “Case Presentation” section, and add the “FINAL DIAGNOSIS”, “TREATMENT”, and “OUTCOME AND FOLLOW-UP” sections to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.</p> <p><b>Editorial Office Director:</b> I have checked the comments written by the science editor.
