interesting, and in detail. The manuscript is well-written, however, a minor editing is required. The questions raised by the reviewers should be answered; and (3) Format: There are 7 figures. A total of 42 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form, and Institutional Animal Care and Use Committee Approval Form. The authors need to provide the Copyright License Agreement (note: The authors list of the Copyright License Agreement is not consistent with the author list of manuscript) signed by all authors and fill out the ARRIVE checklist with page numbers. The study does not involve humans. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Beijing Tsinghua Changgung Hospital Fund; Bethune-Excellent Surgery Fund; and Chen Xiaoping Science and Technology Development Fund. The topic has not previously been published in the WJGO. The corresponding author has published 2 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s).
