2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the chronic liver diseases. The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The manuscript is clear and thorough, with a large sample size a major strength. As the authors themselves make clear, GP73 has been evaluated repeatedly as a potential</p>	[Y]

biomarker for liver disease, and thus use of the word "new" may not be appropriate. The use as a potential prognostic marker is more innovative, but it does not seem to represent the overall conclusions well. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 5 figures. A total of 47 references are cited, including 14 references published in the last 3 years. There are 9 self-citations. 2 Language evaluation: Classification: Grade A. The authors provided a personal language certificate. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Inova Diagnostics Inc. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not write the "article highlight"
