identification methods, antimicrobial susceptibility profile, and determination of resistance genes in *Streptococcus agalactiae*. The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The manuscript is interesting and well written. The discussion is very explicative and the images clarify the manuscript. The article could add further scientific and educational value to the existing literature; and (3) Format: There are 1 table and 1 figure. A total of 43 references are cited, including 4 references published in the last 3 years. There are 2 self-citations. 2 Language evaluation: Classification: Grade B. No language editing certificate was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The title is too long, and it should be no more than 12 words; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6
