2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case report of the unilateral pleuroparenchymal fibroelastosis as a rare form of idiopathic interstitial pneumonia. The topic is within the scope of the WJCC. (1) Classification: Grade D; (2) Summary of the Peer-Review Report: The authors reported a relatively rare case of localized unilateral PPFE. Through interdisciplinary discussion, the diagnosis was confirmed by the course of the disease,</p>	[Y]

histopathology and radiological findings. However, the questions raised by the reviewer should be answered; and (3) Format: There are 3 figures. A total of 17 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C. A language editing certificate issued by eWorldEditing. Inc. was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Written informed consent, but the CARE Checklist-2016 lacks of the page number. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.

Editorial Office Director: I have checked the comments written by the science editor. The manuscript with an only scientific classification of grade D can not be conditionally accepted.
