2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case report of the primary pulmonary plasmacytoma accompanied by overlap syndrome. The topic is within the scope of the WJCC. (1) Classification: Grade B, Grade B, and Grade D; (2) Summary of the Peer-Review Report: This is a very important and well written case. However, the paper was too long, and there were many</p>	[Y]

unnecessary descriptions, which should be deleted. Some mistake should be revised according to the Reviewer 05122811's notes in the attached file. Some references should be added in the right location; and (3) Format: There are 2 figures. A total of 21 references are cited, including 10 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B, and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Written informed consent. No academic misconduct was found in the Bing search. However, the highest single-source similarity index showed to be 6% in the CrossCheck report. The authors need to rephrase the repeated parts. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 9 grants. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); and (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
