2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor: 1 Scientific quality:</b> The manuscript describes a basic study of the hepatitis B virus detected in paper currencies in a densely populated city of India. The topic is within the scope of the WJH. (1) Classification: Grade B, Grade E, and Grade C; (2) Summary of the Peer-Review Report: The authors reported an excellent topic - Hepatitis B virus detected in paper currencies in a</p>	[Y]

densely populated city of India. These results may be highly relevant to COVID-19 infection. However, this study lacks of innovation and science. Thus, the questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 4 figures. A total of 32 references are cited, including no references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B, and Grade B. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The Biostatistics Review Certificate, and the Institutional Review Board Approval Form are not right. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJH. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
