However, there are some issues should be addressed. Structurally article as introduction, Methods, results, and Discussion should be amended and revised. PROMs via electronic media explicitly. There is no real discussion. The questions raised by the reviewers should be answered; and (3) Format: There are 3 figures. A total of 75 references are cited, including 6 references published in the last 3 years. There are 8 self-citations. 2 Language evaluation: Classification: Grade A, Grade B and Grade B. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 8%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJO. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) the author should number the references in Arabic numerals according

The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name, with no spaces. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report and the full text of the manuscript, of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revision.
