The topic is within the scope of the WJC. (1) Classification: Grade D, Grade C, and Grade C; (2) Summary of the Peer-Review Report: The authors investigated the pulmonary functional test and pulmonary</p>	[Y]

hemodynamics in patients who underwent left ventricular assist device. The design is well. However, the typo and grammar mistakes should be revised. The figures should be revised. The questions raised by the reviewers should be answered; and (3) Format: There are 6 tables and 1 figure. A total of 7 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade A, and Grade B. A language editing certificate was not provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form, and the PRISMA 2009 Checklist. Copyright License Agreement is not qualified. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJC. 5 Issues raised: (1) The “Author Contributions” section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main
