Scientific classification does not meet the publication standard of WJGE. There are significant problems in methods and writing of this manuscript. And, it does not present any original findings. 	<p>authors analyzed a database which was recorded for 19 years and study included 140 patients. They showed a significant effort to analyze and present this data. However, there are some major problems in their methods, presentation and writing the manuscript. This manuscript adds nothing to current knowledge and clinical applications. Therefore, I suggest the Editorial Office director reject this manuscript.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: Based on the reviewers' recommendations, the manuscript cannot be accepted for publication in the World Journal of Gastrointestinal Endoscopy.</p>
