(1) Classification: Grade B, Grade B and Grade D; (2) Summary of the Peer-Review Report: Reviewer#02468626 summarized the authors presented an innovative simulator for</p>	[Y]

EUS-elastography using the mechanical properties of polyvinyl alcohol hydrogel for simulating organs and digestive lesions. The study is interesting and well documented. However, a few remarks need to be raised. Reviewer# 03026750 pointed out that some paragraphs in the introduction and discussion are not clear and need paraphrasing. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 9 figures. A total of 15 references are cited, without references published in the last 3 years. The authors need to cite more literatures, and to update the literatures. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade C. The authors need to provide the language certificate of professional language company. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the

	<p>reference list and list all authors of the references. Please revise throughout; (3) this manuscript is an original article, not a review. We suggest the authors choose a suitable manuscript type; and (4) I found the language classification was grade C.
