single-participant study with no comparison to another conservative pain-relieving procedure. More similar studies including more participants will be required to reach more definitive conclusions for such pathologies and a conversion in their management if the original arthrodesis proves not successful. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 8 figures. A total of 11 references are cited, without references published in the last 3 years. The authors need to update the references. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the informed consent, and the CARE checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJO. The corresponding author has not published articles in the BPG. 5 Issues raised: (2) I found no "Author contribution" section. Please provide the author contributions; (2) Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the
