It can provide high-quality timely critical diagnostic and therapeutic information. current pandemic, to add breadth to the manuscript. The questions raised by the reviewers should be answered; and (3) Format: There are no tables or figures. A total of 30 references are cited, including 19 references published in the 2020. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. The manuscript is from the Canada. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has published 2 articles in the BPG. 5 Issues raised: The authors should add some figures or tables. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
