The topic is within the scope of the WJGS. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: In this study, the authors claimed to have developed a method to decrease the development of Petersen's hernia and Roux stasis syndrome. some concerns that should be addressed. An illustration of the surgical procedure should be provided. More information should be provided in the “results” part. The pros and cons of all methods should be discussed. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 1 figure. A total of 25 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. The authors provided a personal language certificate. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The authors need to provide original Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. The authors have published preprints (<https://www.researchsquare.com/article/rs-7268/v1>). 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJGS. The corresponding author has published 2 articles in the BPG. 5 Issues raised: (1) I found the title was more than 12 words. The title should be no more than 12 words; (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (3) I found the authors did not write
