The topic is within the scope of the WJG. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This is a well written paper that needs only minor language/grammar editing. It is not clear when the patients underwent SRS during their FU period. In</p>	[Y]

the discussion section, authors should more thoroughly point out the significance of their findings in terms of what they add beyond the already known, or to compare their findings with the rest of the literature on the subject and present the differences clearly. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 4 figures. A total of 30 references are cited, including 9 references published in the last 3 years. There are 4 self-citations. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 17%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Ministry of Science and Technology Republic of Serbia. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section.
