The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors presented a case with small intestinal angiosarcoma. It is true that angiosarcoma of the small intestine is comparatively rare. However, there are some concerns</p>	[Y]

with regards to the case report. The title is inadequately. The diagnostic methods of jejunal angiosarcoma should be added to abstract. The questions raised by the reviewers should be answered; and (3) Format: There are 4 figures. A total of 10 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by KG Support Limited (Hong Kong) was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the CARE checklist form, and the written informed consent. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 9%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Science and Technology Program of Tianjin; and National Natural Science Foundation of China. The topic has not previously been published in the WJCC. The corresponding author has published 1 article in the WJCC. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); and (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the
