The topic is within the scope of the WJSC. (1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: The authors summarized the current situation regarding the treatment of</p>	[ Y ]

Crohn's disease (CD) with autologous HSCT and to emphasize medical, ethical, legal, and aspects that permeate the procedure in Brazil. The article is well presented and interesting. However, the introduction is too long, it must be shortened and focused on the real topic of the manuscript. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 1 figure. A total of 46 references are cited, including 8 references published in the last 3 years. There are 6 self-citations. 2 Language evaluation: Classification: Grade B and Grade C. The author declared that the English language had been edited by a native English speaker. However, the Reviewer 00503405 pointed out that the English language needed major revision. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The language classification is Grade C.
