and conclusions are interesting. The authors need to present a better description of the methodology on the review carried out. The authors can make a general table (or results) with the results and place the results and compare with the literature. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 8 figures. A total of 25 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B and Grade B. A language editing certificate issued by SNAS was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The authors need to provide original Institutional Review Board Approval Form (Chinese version). Patients were not required to give informed consent to the study because the analysis used anonymous clinical data that were obtained after each patient agreed to treatment by written consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China; and Shanghai Jiaotong University. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s).
