Gastroenterology 2013;144(6):1252-1261.These study revealed a strong association between AP and PC risk within 1 year from AP diagnosis and declined with long-term follow-up.It is well-known, that pancreatic cancer (PC) initially may present with symptomatology similar to mild acute pancreatitis (AP) and may be falsely diagnosed as AP initially. This metanalysis prove this knowledge. Our study is just a statistical finding. That is probably why the relation diminished after 1 year of diagnosis. So many cases were misdiagnosed as AP while they were initially PC. We can try to put forward some hypotheses to explain this phenomenon and revised conclusion, including a comment on "Is AP risk factor for PC or this relation is through other reasons?" in the discussion. Overall, we think the review of first reviewer 69819. is unfair.
