The topic is within the scope of the WJSC. (1) Classification: Grade B, Grade C, Grade C and Grade D; (2) Summary of the Peer-Review Report: This is very important to overcome COVID-19 in the world. The immuno-suppression effect of MSCs on COVID-19 inflammation</p>	[Y]

would be one of the candidate treatments. In general, the review is well and logically written. There is sufficient evidence of the safety and effectiveness of the use of umbilical cord MSCs in the treatment of COVID-19. However, there are some issues should be addressed. Please mention different sources suitable for this potential line of treatment with focusing on advantages and disadvantages of each source. The questions raised by the reviewers should be answered; and (3) Format: There are 2 figures. A total of 66 references are cited, including 23 references published in the last 3 years. There are 7 self-citations. 2 Language evaluation: Classification: Grade A, Grade A, Grade B and Grade C. A language editing certificate issued by Edit Word was provided. The language needs a great deal of polishing. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJSC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI
