The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: Safe and feasible novel endoscopic papillectomy for reducing postoperative adverse events: comparison of a novel method and conventional method is</p>	[Y]

a retrospective study that compared two techniques. This is an interesting study. However, there are some issues should be addressed. The authors need to reduce the introduction part and switch to the topic of discussion. The authors need to add more details in the “method” section. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 1 figure. A total of 33 references are cited, including 2 references published in the last 3 years. There are 2 self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the written informed consent. The Institutional Review Board Approval Form was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Key R&D Program of China. The topic has not previously been published in the WJG. The corresponding author has published 5 articles in the BPG. 5 Issues raised: (1) I found the title was more than 12 words. The title should be no more than 12 words; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using

	<p>PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (4) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, the relevant ethics documents, and the English Language Certificate, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
