The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The title of the manuscript is appropriate to the subject matter discussed in the paper. The authors have used the TCGA HCC dataset to find out the expression level of PLK1 and BIRC5 in a total of 374 HCC data sets. They discovered that</p>	[Y]

co-expression of these proteins is frequently detected in HCC with p53 mutation, which also correlated with poor clinical outcome. However, there are some issues should be addressed. The questions raised by the reviewers should be answered; and (3) Format: There are 8 figures. A total of 23 references are cited, including 7 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Animal Care and Use Committee Approval Form. The Institutional Review Board Approval Form was not applicable. The authors need to fill out the ARRIVE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Science and Technology Major Project; and Tianjin Science and Technology Plan Project. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or
