2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective cohort study of the length unstable femoral fractures. The topic is within the scope of the WJO. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors performed a retrospective chart review of length unstable femur fractures treated with flexible intramedullary nailing at a single institution. An article is well designed, interesting, easy to follow and of great interest for pediatric orthopedists. However, there are some issues</p>	[Y]

should be addressed. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 3 figures. A total of 42 references are cited, including 9 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. The manuscript is from the United States. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the L. Gwaltney McCollum Jr. Endowed Chair in Pediatric Orthopaedic Surgery. The topic has not previously been published in the WJO. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all

	<p>authors of the references. Please revise throughout; (4) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; and (5) the author should number the references in Arabic numerals according to the citation order in the text.
