The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: Authors made the description of the clinical problem of a patient with a pancreatitis, which was previously, misdiagnose as a myeloproliferative disorder. manuscript is well written. Clinical patient characteristics were described properly in the case report. Is a justified conclusion but is lack of the recommendation for the application in the clinical practice. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table. A total of 42 references are cited, including 15 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the written informed consent, and the CARE checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJCC. The corresponding author has not published 1 article in the BPG. 5 Issues raised: The questions raised by the reviewers should be answered. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
