The topic is within the scope of the WJCC. (1) Classification: Grade C, Grade C and Grade D; (2) Summary of the Peer-Review Report: The authors present a rare case and a year and a half follow up of a 27-years old man with Hutch</p>	[ Y ]

diverticulum who underwent a robotic-assisted diverticulectomy with reconstruction. The present report presents an interesting and rare case with educational value for the scientific community. The authors need to add more details in the “case presentation”. The questions raised by the reviewers should be answered; and (3) Format: There are 6 figures. A total of 15 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade B. A language editing certificate issued by Enago was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the written informed consent, and the CARE checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author’s name, with no spaces. 6 Re-Review: Required. 7 Recommendation:
