The topic is within the scope of the WJSC. (1) Classification: Grade B and Grade B; (2) Summary of the Peer-Review Report: The authors have presented the data in very significant way, which have given valuable information of neurotrophic effect in repair of peripheral nerve</p>	[Y]

injury. However, few grammatical and formatting errors should be corrected. The questions raised by the reviewers should be answered; and (3) Format: There are 7 figures. A total of 35 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by SNAS was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and The ARRIVE Guidelines. The Institutional Animal Care and Use Committee Approval Form or Document didn't need. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 3 grants. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list.
