2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the liver injury in COVID-19 patients. The topic is within the scope of the WJG. (1) Classification: Grade B, Grade C, Grade C and Grade C; (2) Summary of the Peer-Review Report: The manuscript has been clearly written, easy to follow and present valuable evidences that are worth to be shared with</p>	[Y] []

the community. However, the study has important limitations as have been well identified and indicated in the text. In spite of drawbacks including the retrospective study design, the limited spectrum of assessed parameters and the lack of data on pre-medication, this evaluation provides interesting information on liver injury in COVID-19 patients in Wuhan. However, there are some issues should be addressed. The work can be improved by increasing the size of the cohort and providing a time-course on the evolution of the liver injury parameters (if available) and the serum markers of inflammation and leukocyte count. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables. A total of 16 references are cited, including 10 references published in the 2020. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade A, Grade A and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not add the PMID and DOI in the reference list. Please

	<p>provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (2) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, the relevant ethics documents, and the English Language Certificate, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
