The topic is within the scope of the WJR. (1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: The authors investigated the potential to use portable ultrasound in ambulance services in Saudi Arabia. It has added some novel knowledge in this emergency area. However,</p>	[Y]

this work did not cover any examples of images being acquired in such mobile scenario. The questions raised by the reviewers should be answered; and (3) Format: There are 12 tables and 13 figures. A total of 17 references are cited, including no references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The Institutional Review Board Approval Form should be the official file. The ARRIVE Guidelines lacks of the page number. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJR. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; and (9) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation. Please re-write the "Case Presentation" section, and add the "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" sections to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Not required. 7
