The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This is an interesting article which cover two not so avid areas of surgical intervention. Firstly, it has covered how cranial drilling can Induce granulation tissue in difficult, non-responding wounds and secondly the use of</p>	[Y]

hyperbaric therapy for promoting faster wound healing and flap survival. Both these aspects are relevant to surgeons, especially those working in peripheral areas; and (3) Format: There are 5 figures. A total of 11 references are cited, including 7 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by MJ was provided. 3 Academic norms and rules: The authors provided the CARE Checklist form and the written informed consent. The authors need to complete the Conflict-of-Interest Disclosure Form and provide the Copyright License Agreement signed by all authors. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the title was more than 12 words. The title should be no more than 12 words; (2) I found no "Author contribution" section. Please provide the author contributions; and (3) Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
