details of the study method was poor, need report the methods in detail, the study sample size was small, and only 20 species in total; and (3) Format: There are 2 tables. A total of 10 references are cited, including 1 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by the Chulalongkorn University English Editing service. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. The study did not involve in any human or animal subjects, therefore, this study does not have signed informed consent form.No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJCC. The corresponding author has 1 published articles in the BPG. 5 Issues raised: No 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
