2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the Retroperitoneal versus transperitoneal laparoscopic lithotripsy of 20-40 mm renal stones within horseshoe kidneys. The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This retrospective study compares retroperitoneal and</p>	[Y]

transperitoneal approaches of laparoscopic pyelolithotomy in horse shoe kidney. However, whether the authors encountered any intra-renal pelvis, what were the problems faced and how did they manage? The question should be answered; and (3) Format: There are 2 tables and 3 figures. A total of 23 references are cited, not including references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. The language was edited by a coauthor. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 1 grant. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
