The topic is within the scope of the WJG. osteoporosis in chronic hepatitis. The sample is small, but it opens up the possibility of larger studies to better assess the risk and benefit of long-term use of the medication. This is a quasi-experimental study, not including a proper control study, rendering the main findings difficult to fully sustain. Description of patients with CLD is rather poorly addressed throughout the manuscript. Due to the design of the study, it is difficult to reach those conclusions, mainly because there is no comparison group nor a sample size estimation. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 4 figures. A total of 44 references are cited, including 10 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A, Grade B, Grade B and Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange
