The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors reported a case of intra-abdominal inflammatory</p>	[Y]

	<p>pseudotumor-like FDCS which was preceded by paraneoplastic pemphigus. This is an interesting case. However, there are some issues should be addressed. The authors need to add more details in the “case presentation” section. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 2 figures. A total of 43 references are cited, including 9 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. The authors need to provide the language certificate, not the invoice. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the written informed consent, and the CARE Checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Required. 7</p>
