2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a review of the mesenchymal stromal cells as potential immunomodulatory players in severe acute respiratory distress syndrome induced by SARS-CoV-2 infection. The topic is within the scope of the WJSC. (1) Classification: Grade C and Grade D; (2) Summary of the Peer-Review Report: The authors presented a good</p>	[Y]

review about mesenchymal stromal cells, but further work to advance the field appropriately was needed, especially some related references should be added. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 2 figures. A total of 121 references are cited, including 83 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade B and Grade C. A language editing certificate issued by BRFAA was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJSC. 5 Issues raised: The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
