The topic is within the scope of the WJSC.</p> <p>(1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This is a well-written paper testing in vitro strategies to obtain a pericyte-like differentiation of human ASCs,</p>	[Y]

which is important to provide a valuable therapeutic strategy for a variety of diseases. However, some questions raised by the reviewers should be solved and answered; and (3) Format: There are 9 figures. A total of 36 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. The language was edited by a native English speaker. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the written informed consent. The manuscript lacks of the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and The ARRIVE Guidelines. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 1 grant. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
