The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This study is mostly well designed and written. In addition, the subject has a good novelty. However, there is not enough information about clinical implication. And if that is possible, please make correlating tables</p>	[Y]

and show results in the abstract too. It will be good helps for clinical practice. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 9 figures. A total of 21 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 5%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an invited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the title was more than 12 words. The title should be no more than 12 words; (2) I found no "Author contribution" section. Please provide the author contributions; (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (4) I found the
