2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor: 1 Scientific quality:</b> The manuscript describes a case report of the kratom induced severe cholestatic liver injury. The topic is within the scope of the WJG. (1) Classification: Grade A and Grade C; (2) Summary of the Peer-Review Report: The authors reported a patient with acute cholestatic liver injury that occurred after only brief use of kratom with histopathological mimicking of</p>	[Y]

primary biliary cholangitis. The authors provided the complete data and good images. The case was interesting and helpful for understanding kratom induced liver injury. In the Table 2, the amount and duration of Kratom use could be important information to include if it is available. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 2 figures. A total of 20 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade A. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the written informed consent, and the CARE Checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the title was more than 20 words. The title should be no more than 20 words; (2) I found no "Author contribution" section. Please provide the author contributions; (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) I found the authors did not add the PMID and DOI in the reference list. Please

	<p>provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (5) I found the “Case Presentation” did not meet our requirements. Please re-write the “Case Presentation” section, and add “FINAL DIAGNOSIS”, “TREATMENT”, and “OUTCOME AND FOLLOW-UP” section to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p><b>Editorial Office Director:</b> I have checked the comments written by the science editor.</p> <p><b>Company Editor-in-Chief:</b> I recommend the manuscript to be published in the World Journal of Clinical Cases.</p>
