The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 3 figures. A total of 35 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. The authors provided a personal language certificate. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the STROBE Statement and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was performed without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. The first author was born in 1980 (under 45 years old). 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted. (Yang Yue)
