Physical Exam	7	Relevant physical examination findings	<u>page 6</u>
Diagnostic Assessment	8a	Evaluations such as surveys, laboratory testing, imaging, etc.	<u>page 6</u>

	8c	Consider tables or figures linking assessment, diagnoses and interventions	<u>N.A.</u>

Interventions	9a	Types such as life-style recommendations, treatments, medications, surgery	<u>page 6-8</u>
