fairly good diagnostic accuracy with selected cutoff of parameters. The main limitation of the present study is the small sample size. that limits the possibility to generalize the findings. Please emphasized the superiority of SE to TE methods, especially in patients with ascites or obesity. Also, more evidence should be added to support conclusion opinion. In addition, the questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 5 figures. A total of 36 references are cited, including 13 references published in the last 10 years. There are 5 self-citations 2 Language evaluation: Classification: Grade A. The authors provided a personal language certificate. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the signed informed consent. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Research Council of Lithuania; Research, Development and Innovation Fund of Kaunas University of Technology; and Research Fund of Lithuanian University of Health Sciences. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. The first author was born in 1981 (under 45 years old). 5 Issues raised: (1) I found the authors did not provide the approved grant
