The topic is within the scope of the WJCC. (1) Classification: Grade A, Grade B, and Grade C; (2) Summary of the Peer-Review Report: Authors retrospectively analyzed the clinical, imaging, and histopathological findings of 14 patients with UESL treated in the Shengjing Hospital</p>	[Y]

of China Medical University. The article is informative and well presentation. The quality of logic and presentation of the key idea are not good. The importance and new insight of this work are not impression compared with previous studies. On the section of Conclusion, the main findings, limitations, and authors' recommendations should be present more clearly and comprehensively; and (3) Format: There are 3 figures. A total of 33 references are cited, no references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B and Grade B. A language editing certificate issued by International Science Editing was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and Written Informed Consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by China National Science and Technology Major Project of Infectious Diseases Control during the 13th-Five Year Plan Period and Liaoning Provincial Local Professional Technology Innovation Platform Construction Project. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not
