The topic is within the scope of the WJCC. (1) Classification: Grade B and Grade B; (2) Summary of the Peer-Review Report: The authors present a detailed account on the surgical treatment of a rare skin neoplasm, with excellent aesthetic results. The case report is clear, comprehensive and valuable. It would be</p>	[Y]

interesting if more information could be provided on the caption of figure 3, further describing the histological characteristics of microcystic adnexal carcinoma. In addition, authors should explain more detail about their first recommended treatment plan that was declined by the patients. The questions raised by the reviewers should be answered; and (3) Format: There are 4 figures. A total of 21 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by LetPub was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form, Copyright License Agreement, the CARE Checklist-2016, and Written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide detailed institutional information for the corresponding author. Please provide detailed institutional information of corresponding author; (3) I found no "Core Tip" section. Please provide the core tip; (4) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can

be reprocessed by the editor; (5) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (6) I found the "Case Presentation" did not meet our requirements. Please re-write the "Case Presentation" section, and add "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" section to the main text, according to the Guidelines and Requirements for Manuscript Revision; (7) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name, with no spaces; and (8) Please write the "Conclusion" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
