| Title | 1 | The words “case report” should be in the title along with the area of focus | <u>1</u> |
| Key Words | 2 | Four to seven key words—include “case report” as one of the key words | <u>2</u> |

| Timeline | 5 | Information from this case report organized into a timeline (table or figure) | <u> </u> |
| Patient Information | 6a | De-identified demographic and other patient or client specific information | <u>3</u> |
| | 6b | Chief complaint—what prompted this visit? | <u>4</u> |
| | 6c | Relevant history including past interventions and outcomes | <u>4</u> |
| Physical Exam | 7 | Relevant physical examination findings | <u>5</u> |
| Diagnostic Assessment | 8a | Evaluations such as surveys, laboratory testing, imaging, etc. | <u>5</u> |
| | 8b | Diagnostic reasoning including other diagnoses considered and challenges | <u>5</u> |
| | 8c | Consider tables or figures linking assessment, diagnoses and interventions | <u> </u> |
| | 8d | Prognostic characteristics where applicable | <u> </u> |
| Interventions | 9a | Types such as life-style recommendations, treatments, medications, surgery | <u> </u> |
| | 9b | Intervention administration such as dosage, frequency and duration | <u> </u> |
| | 9c | Note changes in intervention with explanation | <u> </u> |
| | 9d | Other concurrent interventions | <u> </u> |
| Follow-up and Outcomes | 10a | Clinician assessment (and patient or client assessed outcomes when appropriate) | <u>5</u> |
| | 10b | Important follow-up diagnostic evaluations | <u>5</u> |
| | 10c | Assessment of intervention adherence and tolerability, including adverse events | <u>5</u> |
| Discussion | 11a | Strengths and limitations in your approach to this case | <u>6</u> |
